



This Agreement between _____ (hereinafter referred to as “Client”) and JayCay Dog Services, LLC (hereinafter known as “Trainer”) pertains to the following:

Deposit:

- Client agrees to pay Trainer a \$300 non-refundable fee to secure the training session dates.
- The non-refundable deposit will be applied to the training fee once sessions commence.

Training Fees: Client agrees to pay Trainer a nonrefundable fee in the amount of:

- \$2500-Expedited package of e-Collar training within 7-calendar days
- \$2000-Small Sized Dog package (less than 20 lbs.) which includes 2-weeks off leash training with e-collar
- \$1800-Small Sized Dog package (less than 20 lbs.) which includes 2-weeks on leash training
- \$2200-Medium/Large Sized Dog package which includes 2 weeks on leash training with e-collar
- \$2000-Medium/Large Sized Dog package which includes 2-weeks on leash training without e-collar

- \$50 within 50 miles of the service area of midtown Charlotte, NC
- \$100 within 100 miles of the service area of midtown Charlotte, NC

Dog Health and Vaccinations:

- Client warrants that Dog is physically fit and in good health, free of fleas, parasites, and infectious diseases.
- Client must provide proof of vaccines prior to participating in training services.

Training Services:

- Trainer agrees to provide private lessons for Client's Dog within the contracted time frame.
- Trainer agrees to provide one session to teach Client how to train and work with Dog. Trainer will make every reasonable effort to help Client achieve training and behavior modification goals but makes no guarantee of Dog's performance or behavior because of providing professional animal behavior consultation and services.
- Client understands that he/she and members of the household must follow Trainer's instructions without modification, work with dog daily as recommended, and constantly reinforce training being given to Dog.
- Trainer agrees to provide one follow up session 2-weeks after the completion of training.

Cancellation Policy:

- If Client fails to give at least 24 hours cancellation notice, or is not present at time of scheduled appointment, session fees are still due.

Release of Liability and Indemnification:

- Client expressly acknowledges and understands that Trainer's services will be provided in an environment where certain hazards may exist, including, but not limited to debris in the training area and other animals and their owners, training equipment, water, and other natural hazards.
- Client expressly agrees to indemnify and hold harmless Trainer and Trainer's agents and to pay all losses and damages suffered or incurred, and to defend and indemnify Trainer and Trainer's agents from any claims, demands, lawsuits, losses, costs, or expenses, including attorney fees, arising out of or in connection with the provision of Trainer's services to Client and/or Dog.
- If Dog causes property damage, or bites or injures any dog, animal, or person (including but not limited to Trainer and Trainer's agents), during or after the term of this Agreement, then Client agrees to pay all resulting losses and damages suffered or incurred, and to defend and indemnify Trainer and Trainer's agents from any resulting claims, demands, lawsuits, losses, costs, or expenses, including attorney fees.
- If Dog is injured in a fight or in any other manner during or after the term of the Agreement, Client assumes the risk and agrees that Trainer should not be held responsible for any resulting injuries, losses, damages, costs or expenses.
- At Trainer's sole election, Trainer's duties hereunder shall terminate if (a) in Trainer's sole judgment the Dog is dangerous or vicious to Trainer or any other person or animal, or interferes with the training of other dogs, or (b) Client breaches any term or condition of this Agreement. Upon termination in accordance with the foregoing, Trainer's duties shall terminate but all other provisions of this Agreement shall continue in full force and effect.
- This Agreement is binding upon the Client and any designee of the Client.
- This Agreement supersedes all prior discussions, representations, warranties, and agreements of the parties, and expresses the entire agreement between Client and Trainer regarding the matters described above. The parties confirm that, except for that which is specifically written in this Agreement, no promises, representations, or oral understandings have been made about Dog or anything else. Without limiting the generality of the foregoing, Client acknowledges that Trainer has not represented, promised, guaranteed, or warranted that Dog will never bite, that Dog will not be dangerous or vicious in the future, that Dog will not exhibit other behavioral problems, or that the results of the training will last for any amount of time.
- This Agreement may be amended only by a written instrument signed by both Client and Trainer.

JayCay Dog Services, LLC. Boarding Policies & Legal Stuff

***** Please Read and Initial Each Section *****

1. ___ JayCay Dog Services reserves the right to immediately change your pet's type of boarding if we believe it is necessary to protect the health and well-being of your pet, other pets, or our staff, and Owner agrees to pay any additional costs associated with the change.
2. ___ Owner agrees to pay all costs and charges for special services requested and provide updated vaccination records from your vet before starting boarding.
3. ___ Owner agrees that the pet shall not leave the facility until all charges are paid in full to JayCay Dog Training Services
4. ___ Owner agrees to be solely responsible for all acts or behavior of Owner's pet while it is in the care of JayCay Dog Training Services.
5. ___ Owner specifically represents that they are the lawful and valid owner of the pet, free and clear of all liens and encumbrances.
6. ___ Owner specifically represents that the pet has not been exposed to rabies or distemper within 30 days prior to boarding.
7. ___ Owner agrees that in the event the boarding charges are not paid when due in accordance with this agreement, JayCay Dog Services may retain the pet until the charges are paid. Charges continue to accrue at the agreed-upon daily rate until paid in full. Owner further specifically agrees that a pet that is unclaimed at JayCay Dog Services for ten (10) days beyond its scheduled discharge date is considered abandoned and becomes the property of JayCay Dog Services. Every effort will be made to contact Owner if abandonment becomes an issue. If for any reason the pet is not going to be picked up on the scheduled dismissal date, Owner shall contact JayCay Dog Services to decide to extend the animal's stay and will pay the additional charges based upon the aforesaid daily rate.
8. ___ If the pet becomes ill or if the state of the animal's health otherwise requires attention, JayCay Dog Services at its sole discretion, is authorized to engage the services of a veterinarian or arrange for other requisite attention to the animal up to and including \$500.00. If a veterinarian determines that emergency treatment is needed to save the animal's life or quality of life, and we cannot reach you or the Emergency Contact, we may authorize the veterinarian to perform the emergency treatment. Owner agrees to be responsible for all veterinary costs provided to your animal.

9.____ It is expressly agreed by Owner and JayCay Dog Services that JayCay Dog Services liability in no event exceeds the lesser of the current market value of a pet of the same species or the sum of \$200.00, whichever is less.

10.____ Owner agrees to release, indemnify, and hold harmless JayCay Dog Services from any and all manner of damages, claims, loss, liabilities, costs or expenses, including reasonable attorney’s fees and related costs, arising out of or related to JayCay Dog Services’, except which may arise from the gross negligence or intentional and willful misconduct of JayCay Dog Services, including, without limitation, (i) any inaccuracy in any statement made by yourself or information provided by you to JayCay Dog Services (ii) your dog, including but not limited to destruction of property, dog bites, injury, and transmission of disease, and (iii) any action by yourself which is in breach of the terms and conditions of this agreement.

11.____ Owner warrants and represents that Owner’s pet is not a “show dog” and does not participate in dog shows or cat shows. Owner further represents that Owner generates no revenue or income from the pet’s performance. Owner does not intend, plan or anticipate that its pet will generate revenue or income in the future.

12.____ This Agreement shall be governed by and construed in accordance with the laws of the State of North Carolina. Each party consents to the exclusive personal jurisdiction of the state and federal courts of the State of North Carolina. Owner and JayCay Dog Services must negotiate and mediate in good faith prior to either party filing a cause of action.

13.____ Force Majeure. Neither Owner nor JayCay Dog Services shall be responsible for failure or delay in performing its duties under this Agreement if such failure or delay is due to tornados, thunderstorms, fire, floods, drought, riot, war or other acts of nature.

14.____ Words “you” and “your” refers to the Owner. Conversely, “We” and “our” refers to JayCay Dog Services. Owner and JayCay Dog Services may collectively be referred to as “the parties”, and singularly as a “party”.

15.____ Entire Agreement. This agreement, and any addendums attached, constitutes the entire agreement between the parties. All terms and conditions of this agreement shall be binding on the heirs, agents and assigns of Owner and JayCay Dog Services.
